DISCUSSION/INFORMATION ITEMS

A. Election Debrief – Dr. Colleen Smith (presentation by Dr. Michael Merica)

Dr. Colleen Smith and Dr. Michael Merica updated the Board on the results of the November election and Proposition 410. Dr. Smith talked about the community support we received after the election and some of the local, state, and national issues surrounding higher education. Dr. Nat White reviewed a handout he presented to the Board. His discussion focused on vote numbers, the unique and linked challenges the College faces, and some new ideas to meet these challenges. Dr. White feels that the College needs to make itself more relevant to the general

B. Legislative Update – Mr. Richard Travis

Dr. Colleen Smith updated the Board on the Governor's Achieve60 initiative and some possible support it may provide community colleges.

Mr. Richard Travis updated the Board on his efforts on behalf of the College, the anticipated state budget, what issues might come before the legislature in the next legislative session, and possible opportunities community colleges might have with the legislature.

Dr. Colleen Smith reviewed the results of a survey sent to college employees to gather input on how to use the College's Innovation Funds to move the College forward.

E. Policies and Procedures – Dr. Colleen Smith

Dr. Colleen Smith would like to encourage the College to review all policies and procedures. Dr. Smith would also like to consider a different structure for our policies, procedures, and procedural guidelines. Dr. Smith would like to move towards using only policies and procedures and moving any necessary information from the procedural guidelines to administrative regulations or some other format. The Board was supportive of this suggestion.

The Board would like to have a regular review schedule for all policies and would like to include a review date any time a policy or procedure is reviewed.

The Board discussed areas where the College may need direction from the Board in the near future. Dr. Smith asked for the Board to give direction on taking the levy limit bill back to the legislature. The Board is supportive of moving in this direction.
