D. Early Childhood/Elementary Education – Dr. Nate Southerland

Dr. Nate Southerland discussed the data collected and decision process used to determine the needs for filling full-time faculty positions for the next academic year. Academic Affairs is suggesting that a vacant position in the CIS area be reallocated to restart the Early Childhood and Elementary Education programs.

The Board discussed the previous decision to eliminate the education programs and classes in this area, asked questions about employment needs in education, and the impact elimination of this program has had on credentialing early childhood providers in Coconino County. Dr. Colleen Smith mentioned the Board direction given in October 2018 to hire an education faculty member as soon as funds became available.
