### PRESENTATION OF PROPOSED 2020/2021 BUDGET FOR CONSIDERATION BY THE RESIDENTS AND TAXPAYERS OF THE DISTRICT

The District's budget for fiscal year 2020/2021 totals \$27,502,370 for all funds. It reflects the financial plan of support for the College's educational services through five separate fund groups.

The budget will be allocated to the following categories:

General Fund	\$ 20,913,405
Restricted Fund	\$ 5,870,965
Auxiliary Fund	\$ 42,400
Plant Fund	\$ 675,600

Board members suggested that agenda items related to the annual budget and property tax agenda items include more background on the budget process today and explain the various meetings the Board has held and the agenda items considered to get to this point in the budget process.
