PRESENTATION OF PROPOSED PROPERTY TAX INCREASE

Ms. Jami Van Ess presented the proposed property tax increase.

The proposed primary tax rate for Fiscal Year 2022 is as follows:

Primary Tax Rate	FY 2021
Levy	\$ 8,715,587
Tax Rate per \$100 primary NAV	0.4394

The proposed primary property tax rate does include the maximum increase allowed and the College did follow the legal required notices. Even though this represents an increase to the total levy the College is collecting, it represents a decrease in the tax rate per \$100 in primary net assessed value so property owners will be paying less in property taxes.
