### PRESENTATION OF PROPOSED 2022/2023 BUDGET FOR CONSIDERATION BY THE RESIDENTS AND TAXPAYERS OF THE DISTRICT

The District's budget for Fiscal Year 2022/2023 totals \$32,810,196 for all funds. It reflects the financial plan of support for the College's educational services through four separate fund groups.

The budget will be allocated to the following categories:

General Fund	\$ 23,444,342
Restricted Fund	\$ 8,378,928
Auxiliary Fund	\$ 61,812
Plant Fund	\$ 925,114

Dr. Jami Van Ess presented the proposed 2022-2023 budget to the District Governing Board and the public and explained what was in each of the four main areas of the College's budget. The Board was satisfied with the presentation and did not have any questions.
