A Regular Meeting of the Coconino Community College District Governing Board was held via Zoom on Friday, August 26, 2022. Board Chair, Dr. Nat White, called the meeting to order at 1:16 PM.

CALL TO ORDER

Board Chair Dr. Nat White called the meeting to order at 1:16 pm. Ms. Patricia Garcia expressed that additional time was needed to review the applications for the permanent President position. A week is not enough time for the Board to conduct due diligence. The Board agreed that it was difficult to get through all of the applications, but they were able to review each one and rank them accordingly.

EXECUTIVE SESSION At 1:23 pm, a motion was made by Mr. Eric Eikenberry and seconded by Mr. Patrick Hurley to enter into Executive Session pursuant to A.R.S. § 38-431.03(A)(1) for discussion of Personnel Issues. Dr. Bill Holda advised the Board of the next steps in the process. The Board was given a bank of questions, from which they are to select one or two questions for the Presidential interviewees. Dr. Holda will assemble the list of questions for the semifinalist interviews.
